

## **Table of Local and Private B.C. Statutes**

Prepared by the Staff of the B.C. Courthouse Library Society

### **Introduction**

This is an alphabetical listing of British Columbia's private, local and unconsolidated public acts from 1872 to December 31, 2008. The table includes all acts whether they are in force or not. The table also includes a complete list of amendments and citations for each act.

Private and local acts are acts which only affect a particular person or group, such as an act to incorporate a city or a railway. Due to their limited scope most of these acts are not consolidated or included in statute revisions. Most of these acts are currently available in print only and are in most B.C. courthouse libraries. The statutes are shelved at KP22.

To create this table we began with the Table of Local, Private and Unconsolidated Public Acts, which was included in the looseleaf version of the 1979 *Revised Statutes of British Columbia*. The information was updated using the table of statutes in the annual S.B.C. volumes. We will continue to up date the table at the beginning of each year when the legislature prorogues the session.

### **Using the Table**

Look up the act using the name of the act, city, company, individual or organization. Keep in mind that names may have changed over time. Where there have been complete name changes the current name is used and a cross reference from the old name has been added. Where there are variations in spelling we have kept the spelling that was used in the act.
