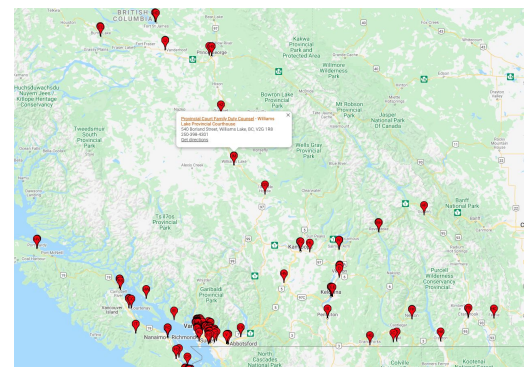
## Solve Legal Problems
