EXPLANATORY NOTE

Amendments Not in Force: If there are any legislative changes to the Act that are not in force as of July 1, 2012, these are identified in *italics* at the beginning of the historical table. The “Section” column identifies the affected provisions of the Act. The “Citation”* column identifies the amending legislation by its citation.

Legislative History: The second part of the table provides a legislative history of each section of the Act between the 1996 general Statute Revision and the 2012 limited revision of this Act. The “Section” column identifies all sections of the Act in force on July 1, 2012. The “History” column for each section begins with the citation of the section immediately before the 2012 limited revision of this Act. This is followed by a list of citations for the legislation that enacted or amended the section between the 1996 general Statute Revision and the 2012 limited revision of this Act (if a section was repealed and replaced during that period, these last citations begin at the most recent replacement).

*Legislative citations have the format of “year-chapter-section”.
