Do-It-Yourself | at your computer

Before making a will, we recommend getting advice from a legal professional by using the resources listed on the right under “Clinics, Registries & Events”, or by getting in contact with a [lawyer](#) or a [notary](#) who specializes in wills.

Public libraries carry some titles that broadly explain wills and estate planning concepts. However, these books may not incorporate the latest BC laws and rules.
